# MINUTES February 9, 2019

The regular meeting of the Round Valley Tribal Council was called to order by President James Russ on February 9, 2019 at 9:15 a.m. in the Buffalo Room in the Tribal Administrative Building located on the Round Valley Indian Reservation.

Item No. 4: Mike Gorman, RV Unified School District – RE: Report - Action Item – 2019-02-09-03: Mr. Gorman was present and gave a verbal report – Bid opening on February 11<sup>th</sup> – five bids were received, they have five million dollars to start (4.5 million/bond and 1 million put away; with PG&E filing bankruptcy, they will do a solar project this summer; electric buses they will get two and the range on these are 100 miles so they cannot be taken out of town; on their Wailacki language was approved and Yuki is being taught now and the students can take

this instead of English; they need a tribal representative on the Impact Aid Committee (they need to send a letter to the Council so it can be placed on the agenda); Prevention Coalition meeting March 26<sup>th</sup> in Sacramento this is in regard to the Prop 54 funds of which 60% go toward schools for drug prevention and education (he invited Council to go with him to this meeting); etc. Discussion followed

Discussion followed and individuals expressed their concerns about the number of students going out on independent study; of students being sent out of the classrooms; of the classrooms being over populated; of organizing activities, no heat in the high school hallway; of phone in the classrooms (why have to have); of the students being bullied by the principal/teachers; of complaints being sent in with no response; of ICWA and what is the chain of command when deals with our Indian Children; of being disrespected by school employees and of being more frustrated when they leave the school; of the importance of attending the School Board meetings (maybe should go in numbers with Council); of the 874 Committee and the need to advertise; etc.
