MINUTES March 1, 2019

The special meeting of the Round Valley Tribal Council was called to order by President James Russ on March 1, 2019 at 9:19 a.m. in the Buffalo Room within the Tribal Administrative Building located on the Round Valley Indian Reservation.

Roll call and the following Council Members were present: Mr. Russ, Mr. Bettega (arrived 9:24 a.m.), Mr. Robert Whipple (arrived 9:24 a.m.), Mr. Rabano Jr., Ms. Cordova & Ms. Willits

- a. Monica Sayad RE: Discussion continued involvement in World Forum & other Impact Action Item 2019-03-01-02: Mrs. Sayad was present and gave an update:
- 1) National Indian Head Start Board set on this board, they have four face to face meetings/four times a year it's an education and advocacy meeting and is one of the members that make up the quorum. She is not going to this meeting in March. She would like to discuss this with the Council if she should continue serving on this Board
- 2) World Forum next meeting will be April 8/11, 2019 in Macao, China. The Council approved for her to attend this last year. This year she is in this group and has been asked to speak and is seeking Council approve to attend, if not she will use her on leave as she is very

dedicated to what they are doing. There are nine representatives on this board and only two are tribal members.

3) Impact Aid 874 – she was asked to participate, she did not know she was supposed to be going to these meetings. She started and was excited and she was vocal on education for the students but it became a very challenging Board to serve on and felt she was not affective, so she has not been attending them.

Short discussion followed about the composition of the 874 Committee; of the Council wanting more accountability of where the funds are going/used;

4) National Indian Education Association - we sent representatives from Head Start Board to attend these meetings, she has not attended these meetings. Most tribes send someone. She encourages someone to attend as it's on Indian Education. Joleen Whipple is interested in attending these meetings - It's for Child Care and is allowable for T/TA

- d. Tracy Comalli-Bettega RE: Sponsor the kids (uniforms, baseballs, bats, etc.) Action Item 2019-03-01-05: Ms. Comalli-Bettega requested that this be done at the end of the meeting.
- e. JD Hoaglen Wright RE: Lack of Tribal Police help Action Item 2019-03-01-06: Ms. Hoaglen-Wright was present along with Ms. Audrina Phillips. Ms. Hoaglen-Wright acknowledged and informed the Council of her concern of Tribal Police not responding to a call she made in regard to Audrina Phillips trailer being on fire. Also, what was happening with Audrina's homesite there has been problems there since 2000, what do they have to do so she can get on her homesite. Ms. Phillips stated that she is coming to the Council for a resolution to

this problem before someone gets hurt. She cannot go over there for fear of being hurt, she would like to go on her lot to start making improvements, but she can't. If this cannot be resolved can she get another piece of land. She asked Mendocino County Sheriffs Dept. about this and they told her she had to come to the Council regarding this matter.

Ms. Hoaglen-Wright asked why can't the Council demand that the individual leave, as Audrina has all her paperwork.

Discussion followed and it was stated that this was the first time that the Council have seen the paperwork and would like time to review it; of taking this matter to tribal court (Mr. Rabano Jr., explaining the process); etc.

f. J. Doreen Hoaglen-Wright – RE: Monolithic Dome Conference - Action Item – 2019-03-01-07: Ms. Hoaglen-Wright stated that she is asking the Tribal Council to send her and her friend to a Monolithic Dome conference (information handed out to the Council) which will held April 9^{th} with the pre-registration the end of this month

Short discussion followed about what the monolithic domes were – are being built on the Navajo Nation at Taloni Lake, Arizona. These domes are relatively new architectural concepts particularly for residential housing – information reviewed.

CTAS – short discussion followed – extended to march 12th; encouraged to apply for CTAS II – for a Planner who could work on the Strategic Plan; also discussed was the Tribal Police and funding availability to pay to retain them and a public safety plan; etc.

iii) Jessica Goodrow/Julia Russ – RE: Indian Education (Diversion) grant
The grant is being worked on. Status show that there is a huge problem with truancy at the school; 19 kids are being bullied; not a lot of students seeking to go to college; looking at funding for a truancy officer, we have a Meth., Officer but is pulled away to address other issues; Ms. Russ is working two hours on this grant in the afternoon, it is time consuming and she is asking for help to put this grant together, as there is a huge gap for education; JOM – is there any

funds in this grant (used for school supplies); of the Tribe's financial problems – no draw downs; etc.
