MINUTES March 14, 2019

The special meeting of the Round Valley Tribal Council was called to order by President James Russ on March 14, 2019 in the Buffalo Room within the Tribal Administrative Building located on the Round Valley Indian Reservation/

Roll call and the following Council Members were present: Mr. Russ, Mr. Bettega, Mr. Whipple (arrived at 1:33 p.m.), Mr. Robert Whipple (arrived at 1:17 p.m. and left at 5:37 p.m.), Mr. Rabano Jr., Ms. Cordova & Ms. Willits

Mr. Keefe informed the Council that the person that should be here is out on leave and that his goal as supervisor of Archaeological is to ensure that consultation is made with the Tribe, on projects they will meet with the Tribal Council as they know that this haven't been that good in the past.

Ms. Petoy added that this project will be on Outlet Creek/South Eel River area to replace the bridge or retrofit it. It was built 1930. They looked at the options – (1 - Retrofit; 2 - Widen; 3 – Replace) and the cost associated with this Project and the environmental impact. The Project projected date to start will be 2020 as there is a lot of field work yet to be done (archaeological and ethnology).

Ms. Patricia Rabano added that she would be working with Mr. Keefe & Ms. Petoy and that a Native American Monitory Agreement needs to be done, so that if any artifacts, etc., is found this would say what would be done with them.

Lengthy discussion followed – public meetings will be held as the public will be impacted as there will be road closures (staging areas, road blocked off, etc.); a meeting with the Council; of

the CRAB Board being involved with this Project; of other ways they could be of assistance to the Tribe when it comes to safety (help easements with CHP; of the Senior walk, etc); of the Lupine; etc.

US Cellular is the only cellular provider in Covelo/Round Valley and because of this the demand for their services has exceeded their systems ability to provide data service speeds that meet the customer's expectations. There is two ideal locations for the towers in Round Valley and these locations were chosen based upon the concentration for demand of US Cellular data and voice service. Proposed plat was reviewed and discussed. After discussion, Mr. Robert Whipple accompanied Mr. Billings to look at the proposed sites.
