# MINUTES April 25, 2019

The special meeting of the Round Valley Tribal Council was called to order by President James Russ on April 25, 2019 at 1:17 p.m. in the Buffalo Room within the Tribal Administrative Building on the Round Valley Indian Reservation.

Roll call and the following Council Members present: Mr. Russ, Mr. Bettega, Mr. Lewis Whipple, Mr. Robert Whipple, Mr. Rabano Jr., Ms. Cordova and Ms. Willits.

ii) Council request meeting with Mendocino County Board of Supervisors Mr. Brown was present and stated that it was brought to his attention that Allman plans to come in and raid the reservation. He sees this as an attack on the Tribe's sovereignty and that he is

over stepping his authority as he was elected to uphold the County laws. Are we going to set back and let this guy come in and assert his will; etc. The Council is elected to protect the members and our sovereignty, we have guarantees and that the Tribe needs to send him the message that he cannot come and do what he wants. Also that the ordinance is still for medical use and it hasn't been amended as now its recreational use.

Lengthy discussion followed and President Russ informed Mr. Brown that the Council at their last meeting directed Ms. Willits to contact Sheriff Allman and set up a meeting with him and the Council and he has been in contact with John Haschak, 3<sup>rd</sup> District Supervisor, so the Council is working on this matter and a meeting will be set with Sherrif Allman.

Mr. Lorn Elk Robe informed the Council that he is in contact with attorney's that work with a tribe in Michigan (who was a 280 state) – retrocede from 280 and there is a check list of how you would go about this. He has placed them on the May 23<sup>rd</sup> agenda to do a presentation to the Council. Discussion followed.
