# **MINUTES** May 23, 2019

The special meeting of the Round Valley Tribal Council was called to order by President James Russ on May 23, 2019 at 1:06 p.m. in the Buffalo Room within the Tribal Administrative Building located on the Round Valley Indian Reservation.

Mrs. Linda Chappabitty was acknowledged and stated that anytime that people talk about programs, she researches this all out and she found a woman in Denver who extracted the oil and they used it in cancer people. This lady is working with Stanford and Stanford received funds to grow plant that this lady used, etc. Mrs. Chappabitty also talked about the Tribe in Washington. If the Tribe was interested in pursuing this avenue she could help out line the program and how Round Valley would fit into this and lay the foundation to legally set up the structure (develop regulations; separate entity; help move the industry forward); etc.
