MINUTES June 20, 2019

The special meeting of the Round Valley Tribal Council was called to order by President James Russ on June 20, 2019 at 1:08 p.m. in the Buffalo Room within the Tribal Administrative Building located on the Round Valley Indian Reservation..

Roll call and the following Council Members were present: Mr. Russ, Mr. Bettega, Mr. Lewis Whipple, Mr. Robert Whipple (arrive 1:12 p.m., left at 7:18 p.m.), Ms. Cordova & Ms. Willits

Mr. McKehan acknowledged and stated that this trail will go from Charlie Hurt road to the town and he has been working on this for two years and they have come up with a design. Some of the things he is working on is property acquisition and to define the middle of the road, fence and mail box relocation. They are also working with one land owner.

The trail will go along the ditch, some consideration is the wet lands, the Corp. of Engineers will need to mitigate this and a letter needs to be sent to EPA so they will know that the Council is aware of this.

And the issues are resolved, the project could start next summer.

Mr. Sookne stated that they are also requesting that the Council appoint a contact person to work with them.
